

AH Advanced Horizontal Unit Heater Pipe Mounting Kit Installation Instructions



WARNING. If the heater is installed on a structure that is to be transported, provide additional support for the heater during transit. The suspended weight should not exceed 250 lbs (114 kg). Refer to the unit heater owner's manual for the mounting specifications and conditions.

Check that your heater model number corresponds to the model number shown on the mounting kit carton.

Step 1

Fasten the Column Stabilizer Bracket (#1) to the wall using the installer supplied fastening method with the slotted holes pointing away from the wall. The Column Stabilizer Bracket (#1) must be mounted at an appropate height to support the top of the pipe.

Installer to supply three 3/8" diameter, grade 5 bolts or equivalent strength fasteners.

Step 2

Install the Base Plate (#5) centered below the Column Stabilizer Bracket (#1) using the Expansion Bolt (#6) or installer supplied fasteners. To install the expansion bolt drill a 3/8" (9.5mm) diameter hole a minimum of 2" (51mm) deep then tap the flarred end of the bolt into the hole. Using the hole in the Base Plate (#5) place it onto the Expansion Bolt and fasten to the mounting surface using a 3/8"-16 UNC Nut (#13) and 3/8" Flat Washer (#14).

Step 3

Using the 3/8" U-Bolts (#7), 3/8" lock washers (#15) and 3/8"-16 UNC nuts (#13) fasten the Stabilizer Angle (#2) and Arm Assembly (#3) at their approximate final location on the 3" Steel Pipe. Leave nuts loose enough to permit parts to moved to final location after pipe is erected.

Note: One piece of 3" Sch 40 or heavier steel pipe cut to required length to be supplied by installer. Maximum length to be 25 ft (7.6 m).

Step 4

Erect the pipe on the Base Plate (#5) that was fastened to the floor in Step 2. Using 3/8"-16 UNC X 1" bolts (#12), 3/8" flat washers (#14), 3/8" locking washers (#15) and 3/8"-16 UNC nuts (#13) fasten the Stabilizer Angle (#2) to the Column Stabilizer Bracket (#1). Position the Arm Assembly (#3) at final mounting height and tighten all fasteners.

Step 5

Bolt AH Bracket, Mounting Attachment (#4) to the heater using 1/2"-13 UNC X 1 1/4" bolts (#8), 1/2"-13 UNC nuts (#9), 1/2" Locking Washers (#11) and 1/2" Flat Washers (#10).

Step 6

Lift the heater into place and fasten it to the Arm Assembly (#3) using a 1/2"-13 UNC X11/4" bolt (#8), 1/2" Flat Washer (#10) and 1/2" Locking Washer (#11).



CAUTION. This step will require more than one person due to the weight of the heater. Refer to the owner's manual for the weight of the heater.


